The front nine opened in 1949, and the back nine in 2007. As Golf Course Superintendent, I am responsible for all aspects of golf course maintenance, including, but not limited to, all agronomic programs (fertilizer, chemical, cultural practices, etc.); daily maintenance; equipment purchases and repair, including golf car fleet; staff hiring, training and safety; budget preparation and monitoring expenses; irrigation system programming, repair, and pump station maintenance; record keeping; short and long-range planning and programs; construction and renovation projects. Responsible to coordinate with Pro and clubhouse staff on tournaments, and course maintenance schedule and activities.
