INTRODUCTION

The intent of this survey and this subsequent publication is to establish baselines, trends, and allocations of resources as they relate to golf course maintenance budgets and today's golf course management.

From April 29th, 2024, through June 12th, a survey was conducted by the Golf Course Superintendents Association of America (GCSAA) to gather information and to study the expenditures, budgeting, and spending habits of golf course superintendents in the United States.

Unique survey invitation links were distributed via email to the sample group of class A and B superintendent members, totaling 7,895 individuals. By default, the unique links can be used only for one survey, preventing ballot box "stuffing" (a total of 1,309 surveys were completed and returned, for a response rate of 17%).

Margin of Error

This response rate is excellent and provides an accurate representation of the entire class A and B GCSAA membership. Margin of error is a theoretical margin of error, plus or minus in percentage points, 95% of the time, on questions where opinion is evenly split. For "average" values, most results will be within +/- 2.4 percentage points range of error with a 95% level of confidence. That is, chances are 19 out of 20 that if all Class A and B members completed and returned their surveys, the average would differ from the sample results by no more than +/- 2.4 percentage points. For many questions, the error range would be smaller than this.

Rounding, Total Responses and Cleaning

Due to rounding, percentages for some questions may not total 100%. Not all respondents answered every question in the survey; therefore, the total number of responses to a question may be less than the total responses to the survey. All studies, no matter how well designed and implemented, must deal with errors from various sources and their effects on survey results. GCSAA examined data for three different kinds of possible errors and eliminated the data from the surveys started. These cleaning parameters are:

- 1. Lack of data 45% or fewer answered questions per respondent, removed entire response.
- 2. Outliers and inconsistencies Values that are so far beyond the typical that they seem potentially erroneous.
- 3. Suspect analysis results Answers to some questions seem counterintuitive or extremely unlikely.

EXECUTIVE SUMMARY

Alone, budgets should never be used to compare golf courses. The averages contained in this report are an amalgamation of many types of golf courses. Golf courses differ in many ways, in far more unique characteristics than can be included in these pages. Due to these vast differences, one must judge the effectiveness of budgetary expenditures by the degree of satisfaction of the golfers that play that golf course, not merely by the number of resources or money spent on maintenance.

Maintenance Budget Breakdown by Region and Facility Type

Respondents were asked to provide their total actual maintenance budget including all labor expenses and excluding capital expenditures. In 2023, the nationwide average maintenance budget for an 18-hole golf course was \$999,585.



This study will focus primarily on the calendar year 2023 actual golf maintenance expenditures. For statistical continuity only 18-hole golf course data was used. In many circumstances, respondents from outside the USA and Hawaii failed to answer in a significant number to result in a meaningful statistic.

Labor

Labor expenditures varied significantly by region, with the North Central spending the lowest amount on labor and the Southwest spending the highest amount. Labor expenditures also vary significantly by facility type, with Private facilities spending the highest amount on labor.

Water

Nationwide, 27% of golf facilities purchase water, up one percent from 2021. Of the facilities that purchase water, the average expenditure in 2023 is \$107,562. Water varied significantly by type of course as well as region.

Largest Expenditures

The largest portions of the golf maintenance budget are summarized in the table below. These six expense categories make up 83% of the total budget at courses overall / nationwide, according to respondents for actual expenditures during 2023. Water was excluded from this list since only 27% of courses purchase water.

Overall nationwide, 71% of respondents estimate that their 2025 maintenance budget will increase. Survey participants say their estimated 2025 expenditures will remain the same at 27%. Just 2% predict there will be a decrease in their facilities approved 2022 budget.

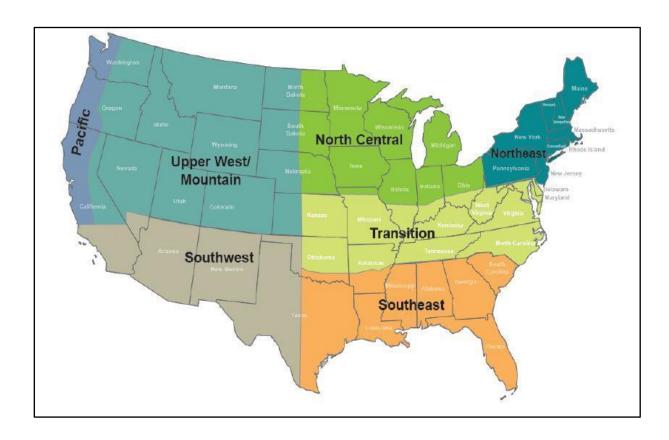

Line items for water and overseeding averages, only include respondents that indicate they purchased water or overseeded. Water and overseeding line items have only been reported by region. These line items are more relevant to regions than types of golf courses.

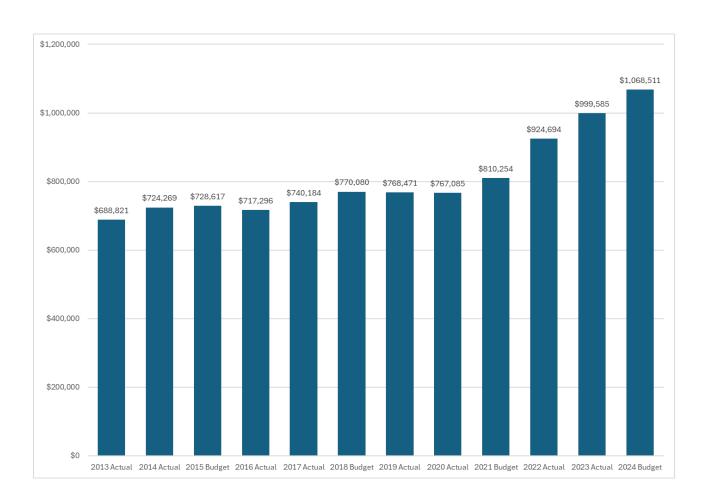
